Languages: Albanian (official), Serbian (official), Bosnian,



## Food and Veterinary Agency

#### **Objectives**

To ensure monitoring and control of contagious animal diseases, zoonosis and animal welfare, to eliminate outbreaks of diseases; to apply all the necessary biological measures for prevention from the introduction of contagious diseases and zoonosis into the territory of Kosovo.

To control and ensure food safety at all stages of food handling, and safeguard the interests of consumers, to ensure that the food placed into the market is safe as well as the food intended for export complies and is safe and are met, labeling and other mandatory requirements established by the legislation.


### Food and Veterinary Agency

#### **ACTIVITY**

The Food and Veterinary Agency (FVA) of Kosovo develops and implements the Government's policy in food safety and quality as well as animal health and animal welfare rules. The FVA reports directly to the Government of Kosovo. The office of the Prime minister)

The FVA as an inspection body is delegated by the Government of Kosovo to carry out inspections in the field of safety, hygiene, traceability and labeling of food and feed and as well as in the field of processing, packaging, distribution, wholesale and retail of food and feed under EU and national legislation.
